

RULES OF THE SUNÊLIA LES SABLONS CAMPING COMPETITION

PRESENTATION OF THE ORGANISING COMPANY

MICAMA, (hereinafter referred to as "the organiser"), a limited liability company with a capital of 216,000€, whose registered office is at Camping Les Sablons avenue des Mûriers 34420 Portiragnes Plage and registered in the Béziers Trade and Companies Register under the number RC69B77.

MICAMA is represented by Mr. Thierry POIROT as manager.

The purpose of these rules is to define the rights and obligations of the Organiser and the participants in the competition.

PARTICIPATION TERMS AND CONDITIONS

The draw is open to all individuals who have booked a stay at the Sunêlia Les Sablons campsite and who meet the following conditions:

The stay booked is for a minimum of 5 nights,

The stay must be booked by 30 May 2021 at the latest,

The stay must be made between 3 May 2021 and 5 July 2021

Participation in the draw is strictly nominative and limited to one person per stay.

This person must be the person in whose name the holiday was booked.

ORGANISATION OF THE DRAW

The draw will take place on 6 July 2021.

This draw will be carried out by means of the RANDOM random number generator software, a device capable of reproducing a sequence of numbers from which no deterministic property can be drawn, so that this sequence can be called a sequence of random numbers.

It will be carried out in the presence of Me BALDY ERIC, bailiff in Béziers, 3 rue Guibal.

The list of reservations from which the draw will be made will be stopped at 30 May 2021 24 hours.

The participants will be numbered.

The draw will be carried out on 6 July 2021 under the supervision of Mr Eric BALDY from the above list.

A list of those drawn will be established.

Thus, if the first person drawn does not accept or expressly refuses the prize, the second person drawn will win the prize, who may refuse and so on.

The winner will be the one who accepts the prize in its entirety and without conditions.

LOT TO BE WON

The person selected at random will win 2 weeks of holiday, i.e. 15 nights, based on the same holiday in 2021 (type of accommodation, number of people).

These nights will be valid until 30 September 2022 (excluding July and August) and must be used under the following conditions:

- The winner may use them subject to
 - o Availability on the dates requested,
 - o The winner will be able to use them subject to: o Availability on the dates requested, Respecting the minimum length of stay according to the site and the dates selected in accordance with our General Terms and Conditions of Sale in force.
- The winner will be able to use and break down the fifteen (15) nights as he/she wishes. Therefore:
 - o He/she may use them in several instalments and without limit,
 - o He/she may use them on a personal basis for his/her own account

The winner will have to commit to share his/her testimony on his/her experience on the SUNELIA LES SABLONS website. His/her testimony may be relayed on the digital media of SUNELIA LES SABLONS (website, social networks, etc.)

The prize won and awarded will be non-transferable.

PERSONAL DATA

ATTRIBUTION OF COMPETENCE

Participants are subject to the French regulations applicable to games and competitions. Any dispute that cannot be settled amicably will be submitted to the competent courts designated in the code of civil procedure.

AUTHORISATION
